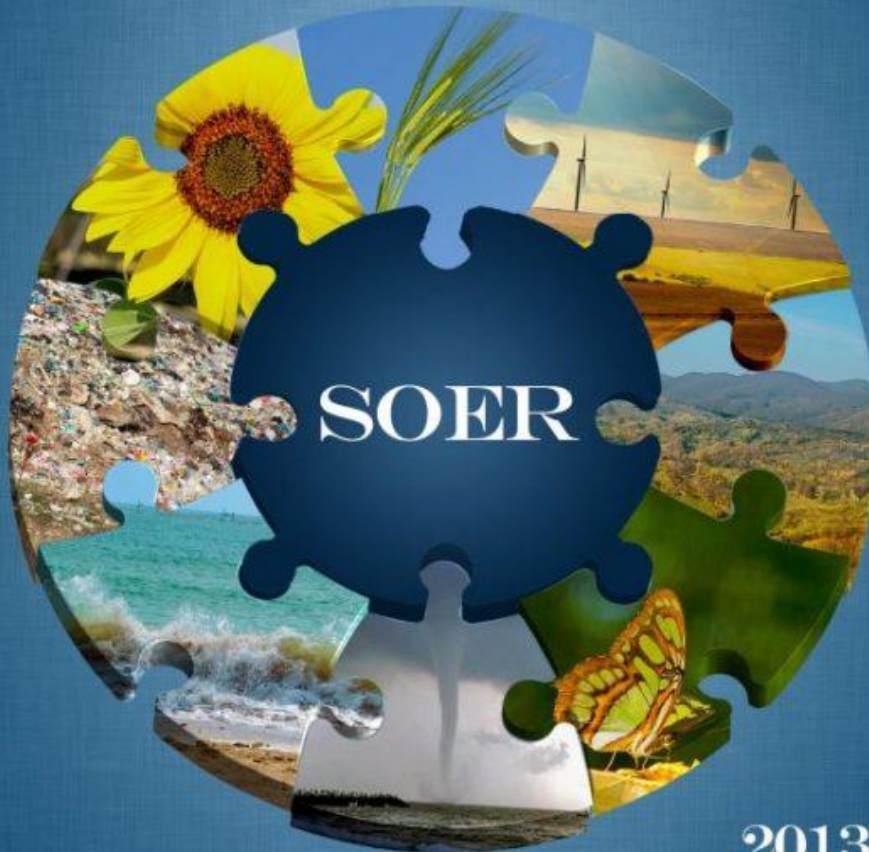

## Objectives

The study aimed at achieving the following **specific objectives**:

1. Identification of the modalities of elaboration of the Annual Report on the state of the environment in Romania, introduction of the set of main indicators of the European Environment Agency in this report, their analysis and interpretation according to SOER.
2. Carrying out a case study – Annual report on the state of the environment in Romania for 2012.
3. Presentation of the ways of elaborating the Annual Report on the state of the environment in Romania in two workshops for the representatives of the National Environmental Protection Agency and the responsible local environmental authorities.

## Results

- Guide for the elaboration of the Annual Report on the state of the environment at national level, as required by the European Environment State Report (SOER). The

Guide presents all the steps necessary for the preparation of the Environment State Report according to SOER and the concrete actions to be taken by each of the stakeholders involved in the implementation of this document.

- Developing a model of Annual Status Report on the state of the environment in Romania for 2012, according to SOER using the data corresponding to 2012. In its realization, data was used owned by NAPM, as well as from other sources of information for each theme and analyzed sector (plans, programs, strategies, environmental targets national and UE).
- Training the environmental authorities and other involved authorities on their obligations in the elaboration of the Annual Report on the state of the environment in Romania and the possibilities for its optimisation in the framework of two seminars on the theme “ANNUAL REPORT ON THE STATE OF THE ENVIRONMENT ACCORDING TO SOER” organised at Bucharest and Brasov.
- Identification and promotion of new means for the dissemination of environmental data and information, easily accessible to the public and the scientific environment, and ensuring active participation of all those interested.
- Increasing cooperation with the Ministry of the Environment and subordinated / coordinated institutions, responsible or complementary to the Annual Report on the state of the environment.
